CALL TO ORDER

The meeting was called to order at 8:01 am. Chairperson Hicks read the statement about how the general public can view and participate in the meeting.

DIRECTOR'S REPORT

There will not be a Director's report this month, it is postponed until next meeting, but the Board was asked if there were any questions--

*Member Harrison asked if the community centers are still open. Director Cooper (via Teams) mentioned that all of the centers are open. Bayview Senior Center's programs are being held outside. The other centers are offering after school programs and small groups and other small events.

STAFF REPORTS

3. Sunshine Law Review - Vanessa Moore, Assistant City Attorney

If any members have any in-depth questions about Sunshine Law, please feel free to contact the City Attorney's office.

* She recommended Government in the Sunshine manual. It is available for purchase or free. [Following the meeting, the Board members were forwarded a link to the manual.]

Sunshine Law consists of two main areas, meetings and public records.

Meetings

* Generally, there is no evil intent of Sunshine Law violations, it is inadvertent. If there is a topic for which the Board members may have a passion, and it is a possibility that it will be discussed at a Board meeting, best advice is to try to avoid voicing an opinion about the topic.

* Sunshine Law requires reasonable notice to be given, minutes to be taken, and that the meeting is open to public. A meeting is any time or any place that two or more members are meeting to discuss business that may come before them.

* Violations can occur in person, via phone, email, as well as if someone relays thoughts or intentions from Board members to another Board member about different issues. It also includes text messages.

* An appearance of a Sunshine Law violation can occur if one is not occurring. Social conversations between Board members are permitted.

* A conflict or potential conflict needs to be disclosed.

* An unintentional violation is a non-criminal infraction, there is often a fine. If it was intentional, it will be a misdemeanor. This applies to all board members and City staff.

* There is no violation if members of the same board attend the same meeting. Board members can listen and participate, but if more than one

shares an opinion about a Board topic, it is a violation. Just be cautious that it does not end up in a Sunshine Law Violation.

Public Records

* Anything in regards to Parks and Recreation Board topics, whether in an email or text, is a public record.

Member Bruni asked if talking to Director Cooper, City Council members, or the Mayor are Sunshine Law violations? Per Attorney Moore, discussions between Director Cooper and the Mayor are generally not subject to public records. City Council are an appointed board also subject to Sunshine Law.

Member Jacquay asked in terms of public notice, if there is a workshop to gain opinions from Board and Council members, what is the proper way to notice the meeting? In particular how to notice a CNAPP meeting, which is a quasi governmental organization? If the meeting is not governmental, they do not need to follow Sunshine Laws, but Board members still need to do so.

Member Escobar-Ryan asked about interactions on social media, do the members need to worry about that? If there issues that can come before the Board, they can be subject to public records, so please keep track. If two people from the same board comment on a topic, it can be a Sunshine Law violation.

4. Value of Trees in Parks - Mark Jackson, Sustainability Coordinator

* Following Hurricane Sally an Urban Forest Strike Team came in to assess the damages in the City Parks. Their objective is tree mitigation, retaining as much viable low-risk tree canopy as possible. Coordinator Jackson presented their findings.

* They suggested several mitigation options, and identified which options could qualify to be reimbursed by FEMA, and which could not.

* They inspected 128 miles of right of ways.

* Three major mitigation efforts that they presented were stumps, remove, prune, and inspect. Inspect means to come back at a later date and inspect the tree again. Sometimes trees can twist during a storm, damaging the inside fibers of a tree. This type of damage will not be visible until a year or two later.

* In regards to value, by living within a half-mile radius of a park that has trees, it adds 15% of value to the property (based on national average).

* In July, the average home price in Pensacola was \$240,000.

* On average, 10% of the trees in parks were damaged.

* There are about 23,500 properties within a half-mile radius of a park with

tree damage.

* On average about \$3,600 was lost per home. He further calculated loss in revenue from property taxes, and it exceeded \$660,000. This loss of tax revenue will not be realized until a property is sold or the property is reappraised by the tax assessor.

* Member Garza asked about replacing the trees that were lost, what trees should be used in their place? Coordinator Jackson mentioned that the City will be working with a consultant to conduct site assessments for a reforestation plan. We will be using the Florida Right Plant, Right Place initiative put out by IFAS (University of Florida Institute of Food and Agricultural Sciences).

* Planting season is now through March, and in that time frame, Coordinator Jackson would like to plant trees in five parks, and the rest next year. The trees will come from native plant nurseries, which take time to grow what we will be purchasing.

* Chairperson Hicks asked if Coordinator Jackson could name the five parks. No, it is outside of his purview.

* Member Jacquay asked if street right of ways will be reforested? Not at this time, but Coordinator Jackson is looking at another project which will encompass those.

* Member Wolf asked if they will be taking this opportunity to remove invasive species such as Chinese Tallow. If the tree was not hazardous, it was not included in the Urban Forestry suggestion for mitigation.

* Member Escobar-Ryan asked if there are any programs to help citizens pay for replacing trees. Coordinator Jackson mentioned that once a year the City's Parks and Recreation department offers a free tree giveaway. There is also a grant available through the Environmental Advisory Board, if the tree is on "common ground".

* Member Jacquay mentioned that since the storm, there is a lot of reluctance to plant a tree that may fall on a house. Coordinator Jackson mentioned again that they need to contact IFAS to get the right tree in the right place.

* Coordinator Jackson mentioned that a tree will add about \$7,100 (based on national average) to the value of a piece of property.

* Alan Gray, citizen, asked what value do we have in assessing street scapes? Per Coordinator Jackson, there has not been a study on home values at this time, but there has been a study that measured the value of a tree in a right of way at \$7,000.

* Mr. Gray also asked about the \$7,500 grant would be available for an entryway into a subdivision. Coordinator Jackson mentioned as long as it is communal property.

* Member Jacquay asked about using the grant for various beautifications in his neighborhood. The grant does not have any clearly defined boxes as to what will/will not be approved besides it has to be communal property. He mentioned that a well developed/presented plan would have an easier

chance of getting funded.

* Chairperson Hicks mentioned that the City's tree ordinance is being rewritten. It should be ready for Council to review and discussion soon.

NEW BUSINESS

6. Lions Park Tree Planting Project - Adam Caton

Adam Cayton is the president of the East Pensacola Heights (EPH) Neighborhood Association.

* The City Council member for that district was willing to use their discretionary tree funds to help with this project at Lions Park in EPH. The park had a lot of open space that could be used for reforestation without interfering with the ball playing activities at the park. There was demand for reforestation.

* The three guiding principals were shade, beauty, and habitat. Lack of shade means people will spend less time in the park.

* After discussions with Council Member Moore, Park Superintendent Bill Kimball, and Director Cooper, the decision was made to plant a mix of native species to create a large central shaded area.

* The Neighborhood Association believes the trees will create higher home values, increasing the amount of tax revenue received, as well as the appeal of the neighborhood.

* The cost of the trees will be about \$4,000, not including labor, but the residents feel it will benefit them once the trees have matured.

* Member Jacquay expressed his gratefulness for implementing this project, but would like to see more benches to enjoy the shade. Mr. Cayton responded that the tree trust fund does not cover benches, so they are saving that project for later.

* Member Wolf suggested using some sort of social media campaign to show off plan and how it was implemented.
