AN ORDINANCE AMENDING SECTIONS 6-3-10, 6-3-12, 6-3-15 and 6-3-19 OF THE CODE OF THE CITY OF PENSACOLA, FLORIDA, ALLOWING DOWNTOWN IM-PROVEMENT BOARD (DIB) TO OPERATE PALAFOX MARKET WITHIN PLAZA FER-DINAND; REQUIRING INTERLOCAL AGREEMENT BETWEEN DIB AND CITY TO GOVERN OPERATION OF PALAFOX MARKET; PROVIDING FOR SEVERABILITY REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
