### DISCUSSION ITEMS

## 1. <u>23-00675</u> SPECIAL MEETING AND PUBLIC HEARING TO ADOPT FINAL MILLAGE RATES AND FINAL BUDGETS FOR FISCAL YEAR 2024

Council President Wiggins indicated the purpose of this special meeting is to conduct the final public hearing to adopt final millage rates for the City of Pensacola and the Downtown Improvement District for 2023 and final budgets for the Fiscal Year 2024. He then read into the record and explained that the TRIM law requires strict conformance with exacting procedures in order to lawfully adopt millage levies and budgets. In adherence with those procedures, he indicated the first substantive issue to be discussed must be the percentage increase over the rolled-back rate necessary to fund the budget, if any, and the specific purposes for which ad valorem tax revenues are being increased; and further that the proposed tentative millage rate of 4.2895 mills for the City and 2.0000 mills for the Downtown Improvement District constitutes an 12.35% increase of property taxes over the aggregate rolled-back rate which is 3.8549 mills. He also stated the basis for the "rolled-back" rate.

He then called on City staff to explain the reasons for the proposed increase over the rolled-back rate.

Finance Director Lovoy provided the explanation indicating the proposed increase over the rolled-back rate is to maintain services and meet increased costs. She responded accordingly to questions from Council Member Brahier; and Council Member Jones made follow-up remarks.
