Please be advised that Proposed Ordinance No. 37-19 was presented to the City Council of the City of Pensacola for first reading on Thursday, December 12, 2019 and will be presented for final reading and adoption on Thursday, January 16, 2020 at 5:30 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida.

The title of the proposed ordinance is as follows:

P.O. #37-19:

AN ORDINANCE INCORPORATING AND ANNEXING A CERTAIN AREA CONTIGUOUS AND ADJACENT TO THE CITY OF PENSACOLA INTO THE CITY OF PENSACOLA, AND DECLARING SAID AREA TO BE A PART OF THE CITY OF PENSACOLA; REPEALING CLAUSE, AND PROVIDING AN EFFECTIVE DATE. (Baptist Hospital Annexation Area – Southwest Quadrant of I-110 and Brent Lane encompassing approximately fifty-three (53) acres)
