The title(s) of the proposed ordinance(s) are as follows:

AN ORDINANCE ADOPTING AMENDMENTS TO THE COMPREHENSIVEPLAN AND ADOPTING THE CURRENTFUTURELAND USEMAP OF THE CITY OF PEN-SACOLA, FLORIDA; REPEALING CLAUSE; PROVIDING AN EFFECTIVE DATE. P.O. #30-19:
