4. [21-00223](#) RATIFICATION OF DISCUSSION PROVIDING DIRECTION ON MOVING FORWARD WITH THE MALCOLM YONGE GYM

Recommendation: That City Council ratify the discussion that took place at a workshop held on February 22, 2021 wherein the Council consensus was to approach Lighthouse Christian Academy about a long-term lease, where market rate would not be an issue, and to explore the possibility of subdividing the lots that currently house the gym.

A motion to approve was made by Council Member Hill and seconded by Council Member Jones.

Council Member Hill (sponsor) referred to discussion from the workshop and explained her intent for bringing this item forward for formal action. She requested an update from City staff regarding discussions with Lighthouse Christian Academy. Parks and Recreation Director Cooper advised of discussions which the school indicated they are not interested in purchasing at this time and relayed what they stated they are willing to pay for rental of the building, repairs, and upkeep of landscaping, plus utilities and taxes. Also, they would allow continuation of current City programming. He clarified that they have not entered formal negotiations but, based on discussion the building needs more funding of repairs than the school can afford.

Discussion ensued among Council (regarding Item 4, 21-00223) with Parks and Recreation Director Cooper, Deputy City Administrator Fiddler, and Mayor Robinson fielding comments and questions. CRA Administrator Gibson also responded to questions related to whether CRA funds may be used to address the needs of the building.

5. [21-00205 ANALYSIS OF GENTRIFICATION DUE TO URBAN REVITALIZATION](#)

Recommendation: That City Council allocate up to \$200,000 or an amount approved by City Council, to hire a consultant to perform an analysis of the impact of urban revitalization in the CRA urban core on the African American population in the city limits and that the consultant provide Council with recommendations to mitigate the dislocation, displacement, economic loss of affordable housing, and community resources in historically African American and low-income communities. Further, the City Council direct the Council Executive to partner with the Community Redevelopment Agency staff in developing an RFP for engaging said consultant.

A motion to approve was made by Council Member Brahier and seconded by Council Member Jones.

Council Member Myers (sponsor) explained the intent of the recommendation and referred to census data provided with the agenda package (and hardcopies at Council's places). She also suggested this issue also be addressed as a CRA project.

Discussion ensued among Council. CRA Administrator Gibson addressed Council advising this topic has come up over the years and discussed by the CRA. She advised of the upcoming CRA Plan update and that staff intends to as a component of that update pursue an evaluation of the possibility of gentrification. She suggested this would be a more holistic and comprehensive approach. Discussion continued with input from Mayor Robinson.
