Please be advised that Proposed Ordinance No. 05-19 was presented to the City Council of the City of Pensacola for first reading on Thursday, July 18, 2019 and will be presented for final reading and adoption on Thursday, August 8, 2019 at 5:30 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida.

The title of the proposed ordinance is as follows:

AN ORDINANCE REPEALING AND REPLACING SECTION 12-10-1 THROUGH SECTION 12-10-6 OF THE CODE OF THE CITY OF PENSACOLA, FLORIDA PROVIDING FOR FLOODPLAIN MANAGEMENT REGULATIONS, DEVELOPMENT STANDARDS AND PROCEDURES FOR CONSTRUCTIONIN AREAS SUBJECTION FLOODING; CREATING SECTION 12-10-7 THROUGH SECTION 12-10-17 OF THE CODE OF THE CITY OF PENSACOLA, FLORIDA; PROVIDING FOR INSPECTIONOF FLOODPLAIN CONSTRUCTION; VARIANCES AND APPEALS; DEFINITIONS REGULATING CONSTRUCTION; VARIANCES AND APPEALS; DEFINITIONS
REGULATING CONSTRUCTION AND SITING OF BUILDINGS, SUBDIVISIONS
MANUFACTURED HOMES, RECREATIONALVEHICLES AND TRAILERS, TANKS
AND OTHER DEVELOPMENTS, CREATINGSECTION 14-1-133 OF THE CODE OF
THE CITY OF PENSACOLA, FLORIDA; PROVIDING FLOODPLAIN AMENDMENTS
SUPPLEMENTAL TO THE FLORIDA BUILDING CODE; PROVIDING FOR
SEVERABILITY; REPEALING CLAUSE, AND PROVIDING AN EFFECTIVE DATE.
