I've observed and spoken with individuals who are unable to pursue passions or even accept a job because they have no access to affordable housing. Alternatively, I have seen how families living in a house that is comfortably within their budget are able to invest more easily in their family's health and future. As a native of Escambla County with deep roots in it, I want to see all of its citizens succeed. I believe that success can only come from work with our County and City and other capable individuals to help every citizen live in housing that acts as a refuge and foundation for their family and not as a burden. I would use my relationships and what I've learned through them, to provide the AHAC with the experiences of Escambia's Citizens to make sure all policies are realistic and effective.

Why do you want to serve on the Committee?

My family has a long history of civic engagement and philanthropy. My grandfather has given millions of dollars to local organizations in Escambia County and my mother was influential in bringing Gulf Coast Kid's House here. My father has been involved in many local organizations including at one time acting on the board of directors for Big Brothers Big Sisters. I grew up in a privileged manner and in a household that strove to convert that privilege into means of making our neighbors' and fellow citizens' lives better. I know of many people whose lives in this community are gravely affected by the availability of affordable housing and am a true believer in the idea that a rising tide lifts all ships. I want to see my fellow citizens of Escambia County succeed, and I feel that one of the best avenues to help them do that is to focus my time and energy volunteering for a committee, such as this Affordable Housing Advisory Committee, that looks for ways to develop affordable housing that serve as good shelter but more importantly can be an asset to a family and not a burden.

## What do you hope to accomplish by serving on this Committee?

Escambia County, and especially Pensacola, has been grappling with a shortage of affordable housing. At a time where COVID restrictions are dwindling and society is ramping back up, there are new issues to address that only add to the already prevalent concerns that have been addressed by this Committee before. While we still must look for avenues that support and finance public and private initiatives that assist with closing costs, home repair, and rent assistance and that encourage developers to create more affordable housing units, the County must also look at problems unique in a post-COVID world. With supply-shortages pushing out timelines of housing projects, the price of materials sky rocketing, and the volatility of the housing market, it is important that the Committee look to known and novel ideas to address these issues. I want to be a part of a Committee that once the term is complete, has provided Escambia County and Pensacola with the best recommendations for addressing our current affordable housing issues while also supplying them with a realistic blueprint for how to incorporate each recommendation.
