



Please be advised that Proposed Ordinance Nos. 25-22, 33-22, and 34-22 were presented to the City Council of the City of Pensacola for first reading on Thursday, August 18, 2022 and will be presented for final reading and adoption on Thursday, September 15, 2022 at 5:30 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida. Members of the public may attend the meeting in person. City Council encourages those not fully vaccinated to wear face coverings that cover their nose and mouth. Members of the public may also attend and participate or via live stream and/or phone as follows: To watch the meeting live visit: cityofpensacola.com/428/Live-Meeting-Video. To provide input:

- For Leroy Boyd Forum, for items not on the agenda: citizens may submit an online form here: <https://www.cityofpensacola.com/cinput> beginning at 3:00 P.M. until 5:30 P.M. only to indicate they wish to speak during Leroy Boyd Forum and include a phone number. Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone.
- For agenda items, proposed ordinance items: citizens may submit an online form here: <https://www.cityofpensacola.com/cinput> beginning at 3:00 P.M. until that agenda item has been voted upon to indicate they wish to speak to a specific item on the agenda and include a phone number. Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone.
