Council Member Jones welcomed Police Chief Randall. He also mentioned he is hopeful for improvements to Mallory Heights Park indicating he is looking for citizen feedback.

Council Member Myers provided updates on the following: 1) Carpenter's Creek Bridge at Davis Highway has sustained damage due to falling trees; 2) Burgess Road improvement project is moving along with Parker Circle Park being used as a staging area; and 3) thanked Transportation Engineer Novota and Interim Public Works & Facilities Director Forte for installation of needed lighting in District 2. Mayor Robinson made follow-up remarks.

Council President Moore thanked local law enforcement for increased efforts and public attention being committed to reducing DUI deaths in response to two recent deaths in the Perdido area with one woman being his mother-in-law.
