On Thursday, November 12, 2020, beginning at 5:30 P.M., in Council Chambers, 1st Floor of City Hall, 222 West Main Street, the Pensacola City Council will hold a regular meeting. During this meeting City Council will conduct hearings to receive the benefit of citizen input for the purpose of considering:

• PUBLIC HEARING: REQUEST FOR ZONING AND FUTURE LAND USE MAP AMENDMENT - 406 NORTH DAVIS HIGHWAY.

• QUASI-JUDICIAL HEARING - FINAL SUBDIVISION PLAT - LAMER PLACE

You are not required to respond or take any action regarding this notice, but if you wish to address City Council on this subject, the following shall apply:

Members of the public may attend the meeting in person; however, there will be limited seating capacity. Consistent with CDC guidelines, attendees will be required to sit at least 6 feet apart and to wear face coverings that cover their nose and mouth.

Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone.

• Agenda items, for specific items on the agenda: citizens may submit an online form here <https://www.cityofpensacola.com/ciinput> beginning at 3:00 P.M. until that agenda item has been voted upon to indicate they wish to speak to a specific item on the agenda and include a phone number. Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone. Any form received after an agenda item has been voted upon will not be considered.

If any person decides to appeal any decision made with respect to any matter considered at this meeting, such person will need a record of the proceedings, and that for such purpose, he/she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
