Sherry/Derrik,

In the absence of a final plan for new sidewalk construction, my interpretation of the sidewalk grid in and around the property on Mallory is that the sidewalk that runs adjacent to 18<sup>th</sup> would not be a critical element in any design to improve connectivity to the parks in the surrounding area. If there is a legal instrument that can bind the owners of the property to reconstructing the sidewalk at their cost in the future, then we can consider letting them remove the existing sidewalk and restore it at a later time. At a minimum, the owners will have to leave enough right of way to

construct a sidewalk, i.e., I do not see a public interest in vacating the RoW to the curb. I will follow up with Lysia on the legal question.
