1. <u>21-00989</u> HOMELESSNESS REDUCTION PROPOSALS FOR AMERICAN RESCUE PLAN ACT (ARPA) FUNDING

Recommendation: That City Council accept the Homelessness Reduction Task Force ranking recommendations and approve the distribution of \$2,575,000 in American Rescue Plan Act (ARPA) funds based on the provided rankings. Further, that City Council authorize the Mayor to set aside \$425,000 for a future distribution to the Lotus Campaign.

Council President Hill explained that this item was previously discussed and postponed by Council at a special meeting on November 10, 2021 and that this meeting was scheduled to address Item-00989. She indicated she would entertain a motion.

A motion was made by Council Vice President Wiggins and seconded by Council Member Moore that Item 21-00989 be brought back to the floor.

Council President Hill summarized the issues before Council related to Item 21-00989 and the options before Council. She also noted that it was determined by Finance Department staff that There Is Hope is not eligible for ARPA funding.

Neighborhood Services Administrator Powell addressed Council on behalf of Mayor Robinson (sponsor) and indicated that it is the intent to bring a proposal forward at the December 16th Council meeting related to the Lotus Campaign and that they be removed from consideration at this time.

A motion was made by Council Member Myers and seconded by Council Member Brahier that the Lotus Campaign be removed from discussion at this time.

Discussion ensued among Council with Neighborhood Services Administrator Powell fielding comments and questions.

Upon conclusion of discussion, Council Executive Kraher clarified the motion on the floor. The vote was called.

Discussion took place among Council regarding the options and issues before Council related to allocation of \$3 million in appropriated funding from American Rescue Plan Act (ARPA) dollars to various organizations for the purpose of reducing homelessness (as presented to Council and discussed on November 10, 2021). Finance Director Lovoy responded accordingly to questions related to funding, risk assessment, and federal guidelines related to expenditure of ARPA dollars. Neighborhood Services Administrator Powell and City Attorney Peppler also responded to guestions related to the encampment of homeless individuals within the Hollice T. Williams greenway under the I-110 overpass.

A substitute motion was made by Council Member Brahier and seconded by Council Member Broughton that City Council allocate funding from American Rescue Plan Act (ARPA) for the following purpose/organizations: 1) Hotel rooms for 15 women and children in the amount of \$180,000; 2) Lakeview Center - Mobile Response Team (dedicated to the people being relocated from Hollice T. Williams greenway under I-110 overpass) in the amount of \$250,000; 3) Bright Bridge Ministries - Bright Bridge (salaries) in the amount of \$281,400; 4) Pensacola Dream Center - Canopy of Hope in the amount of \$300,000; and Re-Entry Alliance Pensacola (REAP) - Navigational Holistic Center (not to include campground) in the amount of \$400,000. Such funding allocations totaling \$1,411,400.

Discussion ensued among Council. During discussion, Melissa Johnson, CEO of Fearless Community, Inc. was provided an opportunity to make clarifying statements (speaking from the audience) and Vinnie Whibbs, Vice President of Development & Director of Operations for Re-Entry Alliance Pensacola (REAP), Inc. was in attendance and called upon to respond to questions (speaking from the podium). Council Executive Kraher made follow-up remarks related to clarification of the substitute motion.

Discussion took place throughout public input with Council Members asking questions of speakers.

Council Member Wiggins requested a friendly amendment to provide funding in the amount of \$300,000. Council Member Brahier accepted.

Council Member Moore asked Council Member Wiggins to elaborate on why he requested an additional \$50,000 which he responded accordingly regarding needs within the community.

Dr. David Josephs, Psy.D., Clinical Director of Lakeview Center, Inc., (who was in attendance) was provided an opportunity to address and clarify their proposal for a mobile response team related to the funding being recommended. **Council Member Moore indicated that his second to the motion stands with the friendly amendment.**

Discussion continued with Dr. Joseph's responding accordingly to questions.

Public input was heard from Michael Kimberl.

City Clerk Burnett asked Council Member Brahier to clarify the motion related to her reference of specific sites for the Mobile Response Team. Council Member Brahier clarified her intent is for the response team to be dedicated to serving people within City limits.

Additional public input was heard from Melissa Johnson.
