Pensacola, Ft., the Pensacola City Council will conduct a public hearing to receive the benefit of citizen input for the purpose of considering the sale of the surplus CRA-owned property at 9th Avenue and E. Romana Street ("Hawkshaw Property") to Robert Montgomery, LLC, for construction of a mixed use development.
