



On Thursday, November 9, 2017 at 5:30 p.m. in the Council Chambers, of City Hall at 222 W. Main Street, Pensacola, FL, the Pensacola City Council will conduct a public hearing to receive the benefit of citizen input for the purpose of considering the sale of the surplus CRA-owned property at 9th Avenue and E. Romana Street ("Hawkshaw Property") to Robert Montgomery, LLC, for construction of a mixed use development. You are not required to respond or take action regarding this notice; but if you wish to speak before the City Council on this subject, you are invited to be present at the scheduled hearing.
