Please be advised that Proposed Ordinance No. 38-21 was presented to the City Council of the City of Pensacola for first reading on Thursday, September 9, 2021; additionally, Proposed Ordinances No. 46-21 and No. 47-21 were presented for first reading on Thursday, October 28, 2021, and each will be presented for final reading and adoption on Thursday, November 18, 2021 at 5:30 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida.

Members of the public may attend the meeting in person. City Council encourages those not fully vaccinated to wear face coverings that cover their nose and mouth.
