**Gloria Horning:** Expressed her frustration with continued flooding in the Tanyards neighborhood which she would like to be addressed especially with continued impacts of on-going and future planned development in the area.

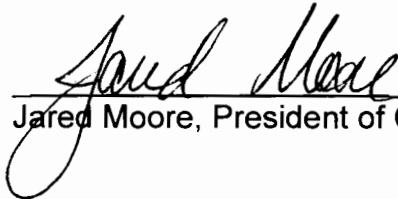

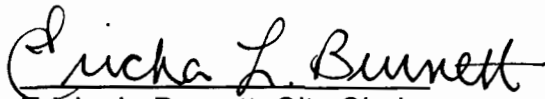
