Please list the reasons for your interest in this position:	Gulf Coast Diplomacy is bringing Northwest Florida from local to global through international exchange and education. We collaborate with the US Department of State to host professional exchange participants via its prestigious International Visitor Leadership Program (IVLP). The IVLP brings up-and-coming young leaders to the US on short-term exchanges. Past participants include Margaret Thatcher, Indira Gandhi, and Tony Blair. Pensacola is one of 84 communities in the nation trusted to host these visitors. Prior to 2020, each year, the State Department sent around 300 international visitors and interpreters to Pensacola via Gulf Coast Diplomacy. These guests stay in our hotels, eat in our
	restaurants, and shop in our stores and downtown boutiques. They make presentations in schools, spend time in classrooms at UWF, and network with area professionals. Currently, we host the IVLP virtually for the State Department and are planning to return to in-person IVLP in 2022.
	We also work with State Department youth exchanges and these have helped us expand our educational offerings to area teens. Having a representative from our organization on the International Relations Advisory Board (IRAB) demonstrates to the US Department of State our region's commitment to promoting mutual understanding and diversity both at home and around the world. When I submit proposals for State Department youth exchanges, my participation on IRAB is always something I highlight.

In the past two years, three local teens were awarded four fully-

	funded US Department of State exchange scholarships, three worked as virtual interns for the State Department, and teens from eight regional high schools have participated in our in- person and virtual youth programs. I view serving on IRAB as a way to serve those youth in our community who are interested in languages, foreign affairs, and leadership.
	Participating on the board also makes it easier for our office to promote Pensacola to international visitors and to coordinate marketing efforts and educational opportunities with fellow board members and City of Pensacola staff through the exchange of timely information.
