

On Thursday, November 14, 2019 at 5:30 p.m. in the Council Chambers of City Hall, 222 West Main Street, the Pensacola City Council will hold a public meeting to consider the following:

- Per the Public Hearing held on September 26, 2019 – City Council will consider the adoption of a Resolution formally correcting Proposed Ord 19-19 and Transmitting Proposed Evaluation and Appraisal-based Amendments to the City's Comprehensive Plan Amendments (and the existing Future Land Use Map without changes) to the Florida Department of Opportunity for review and comment.

You are not required to respond or take any action regarding this notice; but if you wish to speak before the City Council on this subject, you are invited to be present at the scheduled hearing.
