Said lease shall contain provisions for a reversion upon failure to construct or begin construction of a permanent type building within a period of one year from the date of this Resolution, and shall contain an option for the extension of the lease upon its expiration and thereafter revert to the City of Pensacola.

SECTION 2. This Resolution shall take effect immediately upon its adoption by the City Council, and shall be published as required by law.
