1. Call to Order: The meeting was called to order by Chair Trelfa. A quorum was established.

2. Approval of Minutes—May 22, 2019

  - a) Gero, Japan

Summer Visit to Gero

Chair Trelfa reported on the summer visit to Gero. Five students from UWF met with a Jikei group. They spent 8 days in Gero, Anthony Biondolillo arranged activities, school visits and tours for the participants. They met with the Mayor of Gero and expressed the importance of the relationship. Met with the Pensacola Friendship Society in Gero. It was an all around wonderful visit and anticipate going again next year. Hopefully the Brown Barge student group will be able to go next year. They were unable to go this year.

Member Baker expressed the importance of getting participation from middle schools, possibly seeing if students from Episcopal Day School or Creative Learning Center would be interested, since middle school exchanges are a primary focus of the student exchanges. Some scholarship funds will be offered by the Japan America Society.

- 5. Updates—Gulf Coast Citizen Diplomacy Council
  - a) Youth Diplomats

Member Melancon reported that at the Leadership Summit held this summer, two dozen students, including the student delegation from Mexico participated in 13 days of activities. The Youth Diplomats are now at capacity. They hope to recruit more students next year from Navarre and Santa Rosa County.

Member Melancon reported on the recent Open World Ukraine delegate visit as well as another Open World delegation coming from Russia in November. Also, they are working on four other projects involving international visitors that will take place in the next month or so.

#### 6. New Business

Chair Trelfa reported that the University of West Florida just opened the Center for Asian Studies, an evolution of the Japan Program. It is an opportunity to expand into other parts of Asia, offering Chinese and Korean language. They will be holding an academic conference next year to get the faculty at UWF who have interest in Asia to present papers, to reach out to their network and bring in people

to the University of West Florida to talk about Asia, bring in graduate students from Asia. The Confucius Institute agreement was not renewed. They are looking at strengthening ties with Chinese speaking countries and are also engaging with Singapore, China, Taiwan. Japanese and Spanish are the only foreign languages offered for credit at UWF. Other languages are offered through on-line continuing education classes. Enrollments in most foreign languages across the United States are declining. Japanese and Korean are the only languages that are growing in enrollment at the post-secondary level.

Items 3 b), 3 c) and Item 4 will be carried over to the next meeting, which will be October 23, 2019.

The November meeting will fall on Wednesday, November 27, the day before Thanksgiving. **The November meeting will be changed to November 20**. The December meeting will be canceled, since it falls on Christmas Day.
