

Please be advised that Proposed Ordinance Nos. 25-22, 33-22, and 34-22 were presented to the City Council of the City of Pensacola for first reading on Thursday, August 18, 2022 and will be presented for final reading and adoption on Thursday, September 15, 2022 at 5:30 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida. Members of the public may attend the meeting in person. City Council encourages those not fully vaccinated to wear face coverings that cover their nose and mouth.
