RE: Notice of Lawsuit Filed and Legal Advice Relating to November 9, 2017 Legislative Action Item no. 17-00618

As has been previously reported, a lawsuit was filed in Circuit Court on November 3, 2017, styled Daniel D. Lindemann and Gerald W. Holzworth v. The City of Pensacola, the City of Pensacola Community Redevelopment Agency and the Florida Fish and Wildlife Conservation Commission.

At the agenda conference on November 6, 2017, Councilmember Wingate inquired if item # 17-00618 was related to item # 17-00615 which was pulled from the agenda due to the pending litigation.
