The title of the proposed ordinance is as follows:
P.O. #12-18:

AN ORDINANCE CLOSING, ABANDONING AND VACATING A PORTION OF THE 1600 BLOCK OF NORTH 18TH AVENUE RIGHT OF WAY; IN PENSACOLA ESCAMBIACOUNTY, STATEOF FLORIDA, REPEALINGCLAUSE: AND PROVIDING AN EFFECTIVEDATE. (Adjacent to properties located at 1771 E. Mallory Street and 1774 E. Moreno St.)
