AN ORDINANCE CREATINGS ECTION 12-2-25 OF THE CODE OF THE CITY OF PEN-SACOLA, FLORIDA; PROVIDING FOR THE COMMUNITY REDEVELOPMENTAREA (CRA) URBAN DESIGN OVERLAY DISTRICT; PROVIDING FOR SEVERABILIT REPEALING CLAUSE; PROVIDING AN EFFECTIVE DATE.
