2. <u>19-00187</u> AIRPORT - U.S. GENERAL SERVICES ADMINISTRATION (GSA) LEASE AGREEMENT

4. <u>19-00257</u> APPOINTMENTS - ESCAMBIA-PENSACOLA HUMAN RELATIONS COMMISSION

Recommendation: That City Council appoint Patrick Boudreaux, Ron Helms, and Joyce Hopson; and as ex officio Council Member Jewel Cannada-Wynn to the Escambia-Pensacola Human Relations Commission for a term of two (2) years, expiring June 1, 2021.

6. <u>19-00259</u> INTERLOCAL AGREEMENT BETWEEN THE CITY OF PENSACOLA AND ESCAMBIA COUNTY REGARDING THE HUMAN RELATIONS COMMISSION.

Recommendation: That the City Council approve an Interlocal Agreement with Escambia County, Florida regarding the Human Relations Commission, further that City Council ratify the Mayor's action in executing the Interlocal Agreement.

A motion to approve was made by Council Member Cannada-Wynn and seconded by Council Member Moore.

Council Member Cannada-Wynn (as she indicated during agenda conference) expressed concern regarding sufficient funding of operations for the Human Relations Commission to carry out their mission, which she would like further addressed during the budget process. Council Members Myers and Hill made follow-up remarks agreeing further discussion should take place during the budget process, and input from Mayor Robinson also agreeing.

7. <u>19-00249</u> PUBLIC HEARING – PROPOSED AMENDMENT TO THE CODE OF THE CITY OF PENSACOLA – LAND DEVELOPMENT CODE SECTION 12-2-11 AIRPORT LAND USE DISTRICT – RECREATIONAL FACILITIES NOT FOR PROFIT

Recommendation: That City Council conduct the first of two Public Hearings on May 30, 2019 to consider an amendment to the Code of the City of Pensacola, Land Development Code Section 12-2-11- Airport Land Use District - Recreational Facilities - Not-For-Profit.

Planning Services Administrator Morris provided an overview of the issue before Council as outlined in the memorandum (dated 5/30/19). She responded accordingly to questions of Council Members. Mayor Robinson also provided input.

No action was taken at this time. Second Public Hearing is scheduled for June 13, 2019.

8. <u>10-19</u> PROPOSED ORDINANCE NO. 10-19 - AMENDMENT TO THE CODE OF THE CITY OF PENSACOLA - LAND DEVELOPMENT CODE - CREATING SECTION 12-2-25, PROVIDING FOR THE COMMUNITY REDEVELOPMENT AREA (CRA) URBAN DESIGN OVERLAY DISTRICT

Recommendation: That City Council approve Proposed Ordinance No. 10-19 on second reading.

AN ORDINANCE CREATING SECTION 12-2-25 OF THE CODE OF THE CITY OF PENSACOLA, FLORIDA; PROVIDING FOR THE COMMUNITY REDEVELOPMENT AREA (CRA) URBAN DESIGN OVERLAY DISTRICT; PROVIDING FOR SEVERABILITY; REPEALING CLAUSE; PROVIDING AN EFFECTIVE DATE. (Ordinance No. 13-19)

A motion to adopt was made by Council Member Hill and seconded by Council Member Cannada-Wynn.

Based on Mr. Hatler's comments regarding a particular development underway within the proposed boundaries of the overlay district which he indicated would have negative impacts on the continued development, discussion ensued among Council. Mr. Hatler responded to questions with City Attorney Woolf rebutting and responding accordingly to questions of Council Members. CRA Administrator Gibson also provided rebuttal and input.

Based on Mr. Hatler's and Mr. Gunther's comments, Council Member Myers made a motion to amend that the following block be excluded from the Community Redevelopment Area Urban Design District Boundaries: Palafox (on the west), Guillemard (on the east), La Rua (on the north), and Belmont (on the south). Council Member Terhaar seconded.

Discussion ensued among Council regarding the amendment brought to the floor. Mayor Robinson also provided input.

Recommendation: That City Council increase the award amount for Brownfield Cleanup of Submerged Land for the City of Pensacola to H.G. Harders & Son, Inc. of Panama City, Florida for an extension of piling debris removal in Pensacola Bay south of the Community Maritime Park from a not to exceed cost of \$253,000 to \$283,000. Further, that City Council authorize the Mayor to execute all necessary documents to complete the project.
