History / Creation of the Parks and Recreation Board

In 1946, the Parks & Recreation Board was established as a five (5)-member board appointed by the Mayor for a 5-year term.

By 1967, it had become a Board appointed by the City Council making recommendations to the Council and the City Manager (remembering that we functioned under a Council / Manager form of government at that time.)

Fast forward to February of 2010, the Parks and Recreation Board consisted of seven (7) members who were appointed by the City Council. Their duties were to provide, conduct and supervise public playgrounds, athletic fields, recreation centers and other recreation facilities and activities on any of the properties owned or controlled by the City, after the playgrounds, fields, recreation and amusement centers have been designated by the Council, or on other properties with the consent of the owners and authorities. The Board had the power to conduct any form of recreation or cultural activity that will employ leisure time of the people in a constructive and wholesome manner.

Keeping in mind the change in forms of government, any reference to reporting to the City Manager was changed (for the most part) throughout the Code of Ordinances by replacing City Manager with Mayor.

In August of 2012, an amendment to Section 6-2-1 was approved, which brought the number of members to nine (9), appointed by the City Council. The duties at that time remained the same.

In August of 2013, Section 6-2-3 – Duties were amended to read: The Parks and Recreation Board shall advise and make recommendations to the City Council, and shall advise the Mayor's Office via the Director of Neighborhood Services on matters concerning the establishment, maintenance and operation of parks within the city. The Board shall provide input on master plan updates and improvements and policy development for the use of recreational facilities.

In May of 2017, Section 6-2-3 – Duties was further amended, adding "and recreational activities," The Parks and Recreation Board shall advise and make recommendations to the City Council, and shall advise the Mayor's Office via the Director of Neighborhood Services on matters concerning the establishment, maintenance and operation of parks and recreational activities within the city. The Board shall provide input on master plan updates and improvements and policy development for the use of recreational facilities.

The current language as far as the number of members and duties remains the same, with no further amendments taking place since 2017.
