NOTICE OF PUBLIC HEARING

On Thursday, April 23, 2020, beginning at 5:30 P.M., in Council Chambers, 1st Floor of City Hall, 222 West Main Street the Pensacola City Council will hold a regular meeting which some Council Members may be attending by telephonic conferencing. Further, no public may physically be in attendance. This change in format is consistent with Executive Order 20-69 issued by Gov. Ron DeSantis and has been adopted at the direction of Council President Jewel Cannada-Wynn in consultation with the City Attorney. During this meeting City Council will conduct a public hearing to receive the benefit of citizen input for the purpose of considering:

• PUBLIC HEARING: REQUEST TO VACATE ALLEYWAY - BLOCK 29, EAST PENSACOLA HEIGHTS

• PUBLIC HEARING: REQUEST TO VACATE RIGHT OF WAY - PENSACOLA INTERNATIONAL AIRPORT PHASE II

You are not required to respond or take any action regarding this notice; but if you wish to address City Council on this subject, members of the public may attend and participate via live stream and/or phone.

• For agenda items, including public hearing items: citizens may submit an online form here <https://www.cityofpensacola.com/cinput> beginning at 3:00 P.M. until that agenda item has been voted upon to indicate they wish to speak to a specific item on the agenda and include a phone number. Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone. Any form received after an agenda item has been voted upon will not be considered.

If any person decides to appeal any decision made with respect to any matter considered at this meeting, such person will need a record of the proceedings, and that for such purpose, he/she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
