Please be advised that Proposed Ordinance No. 29-20 was presented to the City Council of the City of Pensacola for first reading on Thursday, May 28, 2020 and will be presented for final reading and adoption on Thursday, June 11, 2020 at 5:30 p.m., in Council Chambers on the first floor of City Hall, 222 West Main Street, Pensacola, Florida.

To limit the potential spread of COVID-19, some Council Members may attend by telephonic conferencing and no public may physically be in attendance. This change in format is consistent with Executive Order 20-69 issued by Gov. Ron DeSantis and has been adopted at the direction of Council President Jewel Cannada-Wynn in consultation with the City Attorney. Members of the public may attend and participate via live stream and/or phone as follows:

Staff will call the person at the appropriate time so the citizen can directly address the City Council using a telephone held up to a microphone. Any form received after an agenda item has been voted upon will not be considered.

The title of the proposed ordinance is as follows:

P.O. 429-20:

AN ORDINANCE AMENDING THE CODE OF THE CITY OF PENSACOLA, FLORIDA, TITLE XII LAND DEVELOPMENT CODE, CHAPTER 12-4 REGULATING SIGNS, REPEALING AND REPLACING SECTION 12-4-6 TEMPORARY SIGNS TO CONFORM TO THE REQUIREMENTS OF LAW AND PROVIDING FOR ENFORCEMENT; AMENDING SECTION 12-14-1 DEFINITIONS ENUMERATED; AMENDING DEFINITION OF TEMPORARY SIGNS PROVIDING FOR SEVERABILITY; REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
