Please be advised that Proposed Ordinance No. 29-20 was presented to the City Council of the City of Perascola for Irst reading on Thursday, May 28, 2020 and will be presented for final reading and adoption on Thursday, June 11, 2020 at 530 p.m., in Council Chambers on the First Floor of City Hall, 222 West Main Street, Pensacola, Florida.

To limit the potential spread of COVID-19, some Council Members may atter by telephonic conferencing and no public may physically be in attendance. This change in format is consistent with Executive Order 20-69 issued by Gov. Ron DeSantis and has been adopted at the direction of Council President Jewe Cannada-Wynn in consultation with the City Attomey. Members of the publi

AN ORDINANCE AMENDING THE CODE OF THE CITY OF PENSACOLA, FLORIDA, TITLE XII LAND DEVELOPMENT CODE, CHAPTER 12.4 REGULATING SIGNS, REPEALING AND REPLACING SECTION 12.4-6 TEMPORARY SIGNS TO CONFORM TO THE REQUIREMENTS OF LAW AND PROVISIONS FOR INFORCEMENT, AMENDMIS SECTION 12.1-11 DEFINITIONS ENJIRERATED, AMENDING DISTRIBUTIONS TO TEMPORARY SIGNS PROVIDING FOR SEVERABILITY, REPEALING CLAUSE, AND PROVIDING AN EFFECTIVE DATE.
