AN ORDINANCE AMENDING SECTIONS 142-132 AND 142-133 OF THE CODE OF THE CITY OF PENSACOLA, FLORIDA, ADOPTING THE PENSACOLA REGULATION TO IMPLEMENT CHAPTER 1 OF THE FLORIDA BUILDING CODE: ADOPTING AF PENDICES I AND Q OF THE FLORIDA BUILDING CODE, RESIDENTIAL; PROVIDIN FOR SEVERABILITY, REPEALING CLAUSE: AND PROVIDING AN EFFECTIVE DATE.
