## ESCAMBIA-PENSACOLA AFFORDABLE HOUSING ADVISORY COMMITTEE MINUTES OF REGULAR MEETING

## October 8, 2019

A regular meeting of the Affordable Housing Advisory Committee (AHAC) was held at the City of Pensacola Housing Office on October 8, 2019 at 5:30 PM.

- 1. CALL TO ORDER AND WELCOME AND ROLL CALL: Meeting called to order. Roll call was administered by sign-in sheet.
