Special Meeting Minutes

July 14, 2020

5:30 P.M.

Council Chambers

Council President Cannada-Wynn called the meeting to order at 5:30 P.M. for the purpose of considering two action items related to COVID-19 pandemic.

1. [20-00365](#) HISTORICAL CONTEXT REVIEW OF THE LEE SQUARE CONFEDERATE MONUMENT AND EQUITABLE CONSIDERATION OF ALL PARTIES

Recommendation: That City Council authorize the removal of the Lee Square Confederate Monument. Further, that City Council authorize the Mayor to take all actions necessary to award a contract for the removal and disposition of the monument.

A motion to approve was made by Council Member Moore and seconded by Council Member Hill.

City Administrator Wilkins provided an overview of the information provided within the agenda materials (on file with background materials) that was research provided by City staff, as well as his own thoughts being familiar with the monument since he was a boy.

Mayor Robinson also addressed the staff report and referenced discussions he has had leading up to the recommendation before Council for consideration.

At this time Council Executive Kraher and City Clerk Burnett alternated reading public comments into the record who requested their comments be read during the meeting. Council Executive Kraher confirmed (at the beginning of the meeting) one hundred ten such comments were received (on file with background materials).

ACTION ITEMS (CONT'D.)

Following public input **regarding Item 1 (20-00365)**, at the request of Council President Cannada-Wynn, City Attorney Woolf addressed comments previously made by citizens citing state and federal statutes under such it has been alleged the removal of the monument is not allowable. She referenced a memorandum of her legal opinion (dated July 7, 2020 and emailed on the same date - - on file with background materials) refuting such statutes as not applicable and the reasoning. Mayor Robinson made follow-up remarks indicating the intent of the recommendation is not to destroy the monument, rather respectfully remove and relocate to a more appropriate setting if that is the will of the Council.

Discussion ensued among Council. Based on comments from Council Members, consensus being if the monument is to be removed it be done so quickly and respectfully in collaboration with St. John's Cemetery, if it is the will of their board to have the monument relocated there under their care; and in consultation with UWF's Historic Preservation Trust. Mayor Robinson provided Council with his assurance to handle the monument properly and with the utmost care. Public Works & Facilities Director Owens elaborated on the evaluation of the project and necessary hiring of the appropriate contractor specializing in moving such monuments and approximate timeline.

Upon conclusion of discussion, the vote was called **regarding Item 1 (20-00365)**.

- 2. 20-00337 REQUEST FOR THE RENAMING OF LEE SQUARE TO FLORIDA SQUARE

Recommendation: That City Council approve the request to rename Lee Square back to Florida Square.

A motion to approve was made by Council Member Terhaar and seconded by Council Member Moore.

Mayor Robinson addressed the issue before Council and referenced a map from 1858 (on file with background materials).

Council President Cannada-Wynn inquired of what will replace the monument in the square? Mayor Robinson indicated there is not a recommendation at this time and will bring that issue back for Council's consideration later.

Linda Kallok originally requested to address this item but included her comments when she addressed the previous item.

There being no further discussion, the vote was called.
