# City of Pensacola CITY COUNCIL <br> Special Meeting Minutes 

Council President Hill called the special meeting to order at 5:32 P.M. for the

## ROLL CALL

## ACTION ITEMS

Before addressing the action items, Council President Hill indicated the purpose of this special meeting is to conduct the first public Hearing to adopt tentative millage rates for the City of Pensacola and the Downtown Improvement District for 2022 and tentative budgets for the Fiscal Year 2023, and that the second (final) public hearing will be held at a special meeting on Wednesday, September 14, 2022, at 5:30 P.M. She then read into the record and explained that the TRIM law requires strict conformance with exacting procedures in order to lawfully adopt millage levies and budgets. In adherence with those procedures, she indicated the first substantive issue to be discussed must be the percentage increase over the rolled-back rate necessary to fund the budget, if any, and the specific purposes for which ad valorem tax revenues are being increased; and further that the proposed tentative millage rate of 4.2895 mills for the City and 2.0000 mills for the Downtown Improvement District constitutes an $11.51 \%$ increase of property taxes over the aggregate rolled-back rate which is 3.9659 mills. She also stated the basis for the "rolled-back" rate.

She then called on City staff to explain the reasons for the proposed increase over the rolled-back rate.

Finance Director Lovoy provided the explanation indicating the proposed increase over the rolled-back rate is to maintain services and meet increased costs.

Council President Hill then moved forward with the action items.

Recommendation: That City Council adopt Resolution No. 2022-084:
A RESOLUTION ADOPTING A TENTATIVE BUDGET FOR THE CITY OF PENSACOLA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022; MAKING TENTATIVE APPROPRIATIONS FOR THE PAYMENT OF THE EXPENSES OF THE CITY GOVERNMENT AND ALL DEPARTMENTS THEREOF AND FOR THE PAYMENT ON ACCOUNT OF THE BONDED INDEBTEDNESS OF THE CITY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022; PROVIDING FOR AN EFFECTIVE DATE.

A motion to adopt was made by Council Member Jones and seconded by Council Member Myers.

Public input was heard from the following individual:
Charles Bare: Addressed Council in support of reinstating funding in the Office of City Council for the Legal Counsel position.

Council Members Myers and Brahier made follow-up remarks.
Finance Director Lovoy requested that Council advise City staff during this hearing of any amendments to the proposed budget which they will bring back for consideration at the the final public hearing (on September $14^{\text {th }}$ ). In response, Council Executive Kraher suggested Council address amendments to the proposed budget during (this) initial public hearing.

Discussion ensued regarding amendments to the FY 2023 Proposed Budget as follows:

A motion to amend was made by Council Member Myers and seconded by Council Member Brahier that City Council reinstate the Legal Counsel for City Council position and increase the City Council Personnel Services by $\$ 114,900$ and decrease Temporary Personnel Services in the Mayor's Budget by \$76,600, decrease Repairs \& Maintenance CFO CWFD in Parks \& Recreation by \$36,900 and eliminate the Deputy Parks \& Recreation Director position reducing Parks \& Recreation Personnel Services by $\$ 1,400$.

Discussion ensued regarding the motion to amend with Deputy City Administrator Forte, Parks \& Recreation Director Stills, Recreation Superintendent Byrd, and Council Executive Kraher responding accordingly to questions.

## Resolution No. 2022-084 (cont'd.)

Based on discussion, the (above) motion to amend was withdrawn.
Special Assistant to the Council Executive McLellan suggested wording of a motion to address reinstatement of funding for the Legal Counsel for City Council position.

A motion to amend was made by Council Member Brahier and seconded by Council Member Myers that City Council reinstate the Legal Counsel for City Council position and increase the City Council Personnel Services by \$114,900 and decrease Temporary Personnel Services in the Mayor's Budget by \$114,900.

Discussion ensued regarding the motion with City Administrator Fiddler, Deputy City Administrator Forte, City Attorney Peppler, and Special Assistant to the Council Executive McLellan responding accordingly to questions.

Upon conclusion of discussion and there being no public input, the vote on the motion to amend was called.

The motion to amend failed by the following vote:

Council Member Moore addressed improvements needed for Pintado Park and that Local Option Sales Tax (LOST) funding allocated for Baars Park could be shifted since development restriction for that park have been imposed by Council.

Motion to amend was made by Council Member Myers and seconded by Council Member Jones to shift LOST funding currently allocated to Baars Park in the amount of $\$ 150,000$ to (new line item) for Pintado Park in the amount of \$150,000.

Some discussion took place with Finance Director Lovoy and Special Assistant to the Council Executive McLellan responding accordingly to questions.

Upon conclusion of discussion and there being no public input, the vote on the motion to amend was called.

Motion to amend was made by Council Member Myers and seconded by Council Member Brahier to reinstate half of the ADA funding by increasing Parks \& Recreation Repairs and Maintenance by $\$ 50,000$ and decreasing the funding for the Deputy Parks \& Recreation Director.

Discussion took place with Deputy City Administrator Forte and Finance Director Lovoy fielding comments and questions. Finance Director Lovoy suggested instead of decreasing the funding for the Deputy Parks \& Recreation Director to decrease funding for the Friends of Downtown by $\$ 50,000$. Further that within the CRA Fund, increase Other Contractual Services by $\$ 50,000$ and decrease Professional Services by $\$ 50,000$. Council Member Myers and Council Member Brahier agreed to accept as a friendly amendment.

There being no further discussion and no public input, the vote on the motion to amend was called.

The motion to amend carried by the following vote (with Council Member Jones absent):

A motion to amend was made by Council Member Broughton and seconded by Council Member Wiggins to add a Program Specialist for the Arts position by increasing the Parks \& Recreation's Personnel Services budget by $\$ 57,600$ and decreasing the funding for the Deputy Parks \& Recreation Director by $\$ 57,600$.

Discussion took place with City Administrator Fiddler and Deputy Administrator Forte explaining that positions recently added for Cultural Affairs would cover arts programing. Council Member Broughton withdrew her motion.

Council Member Brahier indicated that she would like to make a motion to amend to address changes to the City Clerk's budget. Special Assistant to the Council Executive McLellan suggested wording of a motion as follows: to increase the City Clerk's personnel services budget by $\$ 154,300$ in order to change the City Clerk from SES II to SES III and receive same benefits as Department Directors, change the Assistant City Clerk (NU-23) to Deputy City Clerk at SES II, provide a $10 \%$ increase for the Public Records Clerk and add one (1) Administrative Assistant II and eliminate the Planning Services Director position in Development Services reducing Development Services Personnel Services by $\$ 107,800$, reduce Repairs \& Maintenance CFO CWFD in Parks \& Recreation by $\$ 36,900$ and reduce Other Contractual Services CFO CWFD in Parks \& Recreation by $\$ 9,600$ with a motion to amend by Council Member Brahier and seconded by Council Member Broughton.

Discussion ensued (regarding the motion to amend addressing the City Clerk's budget) with input from Deputy City Administrator Miller indicating Mayor Robinson is supportive of addressing the changes in classifications of the City Clerk and Assistant City Clerk positions and made comments offering a revised motion related to increased salaries (referencing the Human Resources Manual), FRS benefits, auditing of the Clerk Public Records Coordinator position, and not including the added Administrative Assistant Il position.

Council Member Brahier clarified it is the intent of the motion to include that the next opportunity for the City to add a senior management level benefit for the Florida Retirement System (FRS) would be provided for the City Clerk. Council Member Broughton agreed.

Discussion continued regarding the motion to amend with additional input from City Administrator Fiddler, Human Resources Director Kirchharr, Deputy City Administrator Forte, and Special Assistant to the Council Executive McLellan. City Clerk Burnett also responded accordingly to questions regarding the request for an additional position to assist with public records requests.

Upon conclusion of discussion and there being no public input, the vote on the motion to amend was called.

Council Member Brahier addressed needed improvements for Belvedere Park, Fairchild Park, and Eastgate Park. Discussion took place with Parks Superintendent Kimball Parks \& Recreation Budget Manager Weekley, and Finance Director Lovoy responding to questions explaining funding of proposed improvements.

A motion to amend was made by Council Member Brahier and seconded by Council Member Myers to add \$100,000 to Fairchild Park and \$139,024 to Belvedere Park and reduce the Soccer Complex by $\$ 119,024$ and $\$ 120,000$ from General Park Improvements.

Discussion took place regarding the motion to amend with Deputy Administrator Forte, Parks \& Recreation Director Stills, and Finance Director Lovoy responding to questions.

Addressing DIB pressure washing a motion to amend was made by Council Member Brahier and seconded by Council Member Wiggins (with Special Assistant to the Council Executive McLellan aiding in wording) to shift funding of $\$ 6,500$ from Other Contractual Services within Development Services for the DIB Pressure Washing and offset with an increase of $\$ 6,500$ for the establishment of a budget for the American Creosote Works Property Acquisition. Further, that within the CRA Fund, Other Contractual Services be increased by $\$ 6,500$ and offset with a reduction in Professional Services within the CRA Fund.

Discussion took place with Deputy City Administrator Forte, Deputy City Administrator Miller, City Administrator Fiddler, and Development Services Director Morris responding to questions regarding License to Use Agreement Fees.

Upon conclusion of discussion and there being no public input, the vote on the motion to amend was called.

Addressing Veteran's Memorial Park janitorial services a motion to amend was made by Council Member Brahier and seconded by Council Member Moore (with Special Assistant to the Council Executive McLellan aiding in wording) to decrease $\$ 16,000$ funding in Other Contractual Services in Parks and Recreation and offset with an increase of $\$ 16,000$ for the American Creosote Works Property Acquisition. Further, that Other Contractual Services within the CRA Fund be increased by $\$ 16,000$ and offset with a decrease of the same amount in Professional Services in the CRA Fund.

There being no discussion and no public input, the vote on the motion to amend was called.

The motion to amend carried by the following vote (with Council Member Myers no longer in attendance):

Further, within the Tree Planting Trust Fund appropriate $\$ 50,000$ for Operto Park landscape and irrigation improvements and increase the Fund Balance within the Tree Planting Trust Fund.

Council Member Brahier made comments regarding concerns from nearby residents related to use of the basketball courts after dark. Council Member Broughton made follow-up remarks.

Further that within the Recreation Fund an increase of $\$ 25,000$ in Other Contractual Services offset with an increase in Fund Balance drawdown in the same amount.
