1. [22-00827](#) CLARIFICATION OF INTENT REGARDING COUNCIL'S DECISION RELATED TO 313 EAST JACKSON STREET - REQUEST TO KEEP UNAPPROVED ROOFING

Recommendation: That City Council clarify their intent regarding their decision related to 313 East Jackson Street regarding the request to keep unapproved roofing.

Since the purpose of this special meeting is to obtain clarification on the intent regarding Council's decision during the special meeting of June 22, 2022 (quasi-judicial hearing), Council Executive Kraher suggested that both Assistant City Attorney Lindsay and Nanette Chandler (appellant) be provided five (5) minutes each to address Council. Then Council deliberation may take place to determine the drafting of proposed language for the deed restriction.

City Attorney Lindsay and Ms. Chandler each addressed Council (as set forth above).

Council's deliberations took place. Upon conclusion of deliberations, Council Executive Kraher suggested, for clarity, that Council entertain a motion and vote clarifying the intent of their decision at the special meeting on June, 22, 2022.

A motion was made by Council Member Myers and seconded by Council Member Brahier (with wording assistance provided by Council Member Moore) that the intent of City Council's action on June 22, 2022, was captured in the language of the proposed deed restriction, as drafted by Assistant City Attorney Lindsay (on file with background materials).
