

2. <u>21-00746</u> SELECTION OF LEGAL REPRESENTATION FOR THE DISTRICTING COMMISSION

Recommendation: That the City of Pensacola Districting Commission select the firm of Clark Partington of Pensacola in partnership with the Pittman Law Group of Tallahassee to provide legal representation for the Commission. Further that the Commission authorize the Chair to take all actions necessary to engage these firms.

DISCUSSION ITEMS

3. 21-00745 PRELIMINARY CENSUS NUMBERS

Supervisor of Elections Stafford addressed the Commission referencing *Preliminary 2020 Pensacola Census Data* (attachment 1 of related memo and hardcopies provided) along with an additional hand-out *2020 Census Data – Pensacola, FL* (placed on file with background materials). Discussion took place regarding the data as broken down by district and demographics and looking at which districts may need to have boundaries redrawn. Also provided via email and hardcopies, from the U.S. Department of Justice (DOJ), *Guidance under Section 2 of the Voting Rights Act, 52 U.S.C. 10301, for redistricting and methods of electing government bodies (published 9/1/21).* SOE Stafford and Chairperson Mack fielded comments and questions throughout discussion.

Chairperson Mack suggested the next step be for SOE Stafford to review and bring back to the Commission data from districts adjacent to District 5 and which census blocks have the densest Black (or African American) voting age population (VAP) and demonstrate (via data software) how that would impact those other districts. *No objection from Commission Members or SOE Stafford.*

Brief discussion also took place between Chairperson Mack and SOE Stafford referencing data software utilized by the Supervisor of Elections Office versus GIS software utilized by the City and use by the Commission to assist in analyzing data.
