**SUBJECT:**

APPRAISAL BRUCE BEACH PROPERTY

**RECOMMENDATION:**

That City Council obtain an appraisal to determine the fair market value of the 44.45 acres of land known as Bruce Beach and report the findings to the City Council at the next Council meeting in December of 2017.

**HEARING REQUIRED:** No Hearing Required

**SUMMARY:**

In August of 1980, City Council passed Resolution No. 36-80 which declared the intent of the City Council to cause the development of specified Inner City Properties for the Public Benefit, one of those properties was Bruce Beach.

In September of 1980 the City Council passed Resolution No. 55-80 which created the Community Redevelopment Agency and further dedicated and assigned certain undeveloped and underdeveloped properties identified in Resolution No. 36-80 to the Community Redevelopment Agency for the purpose of promoting, planning, packaging and accomplishing the redevelopment of said properties in accordance with the basic land use intent and methodology set forth in Resolution No. 36-80. Bruce Beach was one of those properties.

In May of 2014, the City entered into a Lease agreement with the Florida Fish and Wildlife Commission for the Lease of the property known as Bruce Beach for the construction of the Gulf Coast Marine Fisheries Hatchery/Enhancement Center at a lease price of \$50 per year.

The intent of this item is to educate the Council and the public as to the fair market value of this property.
