SUMMARY:

The Florida Legislature has enacted Florida Statues § 403.7033 which prevents local government, local agency or state agency from enacting, "any rule, regulation, or ordinance regarding use, disposition, sale, prohibition, restriction or tax of such auxiliary containers, wrappings, or disposable plastic bags," until such a time that the Legislature adopts recommendations of the Department of Environmental Protection. To date the Legislature has taken no action.
