# ESTABLISHMENT OF A COMMUNITY REVELOPMENT AGENCY (CRA) ADVISORY BOARD

# **RECOMMENDATION:**

That the Community Redevelopment Agency (CRA) recommend that City Council sunset the Westside and Eastside Redevelopment Boards and establish a single CRA Advisory Board to provide for citizen input for all three (3) redevelopment areas. Further, that the advisory board shall be comprised of two (2) residents or business owners from the Urban Core, Westside and Eastside redevelopment areas, respectively, for a total of six (6) members.

## SUMMARY:

On March 14, 2013 and September 11, 2014, the City established the Eastside Redevelopment Board and the Westside Community Redevelopment Board to provide for neighborhood participation from the Westside and Eastside redevelopment area neighborhoods under Section 163.2517, Florida Statutes. A board was not established for the Urban Core redevelopment area.

To provide for participation from the Urban Core redevelopment area, it is recommended that the Community Redevelopment Agency (CRA) recommend that City Council sunset the existing Westside and Eastside Redevelopment Boards and establish a single CRA Advisory Board to provide for citizen input for all three (3) redevelopment areas. Further, that the advisory board shall be comprised of two (2) residents or business owners from the Urban Core, Eastside and Westside redevelopment areas, respectively, for a total of six (6)
